Further, such ADR services rendered must include only instances in which zero compensation has been received by any person, organization, or entity from parties, unless otherwise approved by the Commission [on Dispute Resolution]. Volunteer neutrals do not include court ADR program or court staff who receive any compensation, including wages, from a court, government office, or local ADR board.
